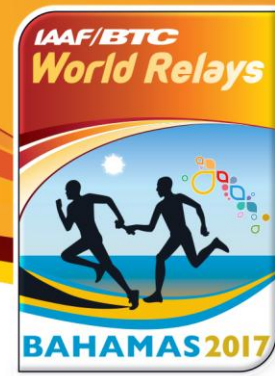


AGREEMENT BETWEEN THE LOCAL
ORGANIZING COMMITTEE OF THE IAAF
WORLD RELAYS BAHAMAS 2017, AND
THE FOOD VENDOR



The IAAF World Relays Bahamas 2017 will be the third world relays to be held. This event is similar to other world athletic events held around the globe annually. It is very strictly controlled and everything is time driven. This includes the service of food.

Spectators will be here to watch the relays. Any time spent away from their seats may result in them missing a race. In order to ensure that spectators and vendors achieve their goals, it is suggested that vendors keep in mind that time is important to all spectators.

Because of these facts, we suggest that careful consideration be given to what food items vendors decide to sell taking into account how long it takes to prepare and serve certain foods. Spectators will require fast, efficient service of tasty, well prepared food items.

Food Vendors are being requested to set up and supply spectators during the 2-day event: Saturday April 22nd and Sunday, April 23rd. Vendors will only be allowed to supply food. No beverage will be allowed.

SERVICES PROVIDED

Power: 20 amps
Lighting: one
Tables: two (2) eight foot tables
Chairs: two (2)
Signs: Booth and menu board with prices

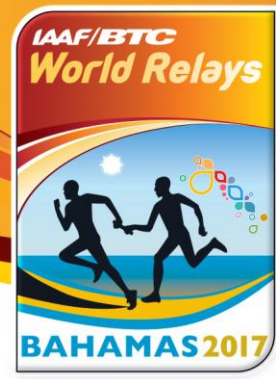
The Food Vendor will pay for 1 space. The details for the space are:

Size: 9ft x 9ft booth
Cost: U\$1,000 per space

All vendor booths will be placed on the apron around the stadium.

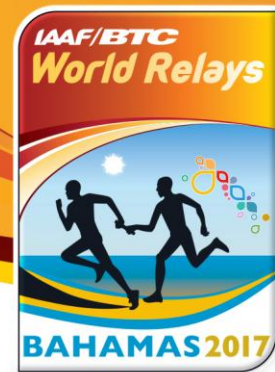


TERMS AND CONDITIONS

1. The Food Vendor, by signing this Food Vendors Agreement, agrees to abide by all terms and conditions set out in this Agreement.
2. The Food Vendor must have a Bahamas Government issued Vendors Permit to be submitted with this application.
3. All Food Vendors must present a Valid Health Certificate with this application.
4. The Food Vendor must provide proof of liability insurance naming the LOC and the National Sports Authority as additionally insured or sign a waiver.
5. All Food Vendors and helpers must meet and follow all Department of Health food handling standards and guidelines.
6. All Food Vendors must provide appropriate hand cleaners or/sanitizer. Running water is available on the grounds of the event.
7. All Food Vendors and helpers must wear hairnets or hats and food handler gloves.
8. All Food Vendors with containers of Butane Gas or LPG must have the same affixed to a secure stove and must be managed with due care and attention at all times. Food Vendors using LP Gas are advised that the largest allowable tank size is 20lb. A recently inspected, dry chemical fire extinguisher is required. The extinguisher should be at least 5 lbs.
9. Booth locations will be determined by the LOC. Locations are not interchangeable without LOC approval.
10. The Food Vendor must use booths provided. Any special requirements outside of the original specifications of the booth will require an additional charge.
11. All business and other activities, for which the Food Vendor has rented space, must be conducted within the designated booth space only. No distribution, canvassing, flyers, nor vending of any kind may be done by strolling through the stadium.
12. Booth fee is **NON-REFUNDABLE**, regardless of booth placement or sales.

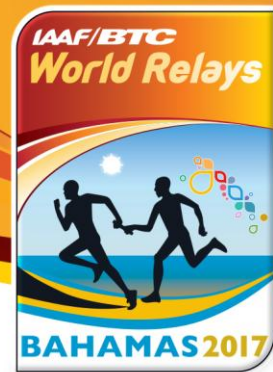




13. **ACCEPTED FOOD VENDOR'S BOOTH FEE MAY BE PAID IN CASH OR BY CHEQUE. CHEQUE MUST BE MADE PAYABLE TO: IAAF WORLD RELAYS BAHAMAS AND MUST BE RECEIVED BY APRIL 5TH 2017.**
14. Check-in time on April 22nd and April 23rd begins at 8:00am and Food Vendor must be completely setup by 2:00pm. Food Vendor are required to be open from 3:00pm to 10:00pm.
15. **CLOSING BEFORE THE END OF THE EVENT IS STRICTLY PROHIBITED AND IS GROUNDS FOR EXPULSION AND PARTICIPATION AT FUTURE EVENTS.**
16. Food Vendor's parking is located at the Service Providers parking lot (Lot 5).
17. All Food vendors and helpers must be properly uniformed.
18. Consumption of alcoholic beverages by vendors, volunteers or employees is prohibited.
19. The Food Vendor will be responsible for all of his/her own food and equipment; the LOC will not be liable for lost, stolen or misplaced food or equipment at the event.
20. Once Approved the Food Vendor must provide menus and pricing to the LOC by 4:00pm April 5th (see attached form).
21. The LOC will provide trash receptacles for waste generated at booths. **IMPROPER TRASH DISPOSAL IS GROUNDS FOR EXPULSION AND EXCLUSION FROM PARTICIPATION AT FUTURE EVENTS.**
22. Clean-up and breakdown of booths must be completed at the close of business on April 23rd, 2017.
23. Storm Drain Policy: At no time is trash, debris, grease or any type of liquid to enter a storm drain. Vendors must dispose of all pollutants such as trash, dirt, unfinished beverages, and any other type of trash in the proper manner.
24. Failure to comply with the LOC's policy will result in forfeiture of deposit and expulsion from the current and possible future events.
25. All Vendors must attend a mandatory meeting on Monday, April 10th at 5:30 pm.
26. All Food items must be stored inside the allotted space, covered and off the ground.

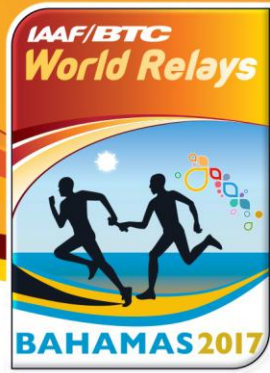


27. All Vendors must provide their own tablecloths. They must be fresh and clean daily.
28. All Food Vendors must pay **\$200.00** as a **security deposit** which will be refunded after the vendor's booth space has been inspected at the end of the event and found to be free of any damage. The deposit can be made with cash or cheque made payable to the IAAF World Relays Bahamas 2017.
29. **SUBMISSION OF AN APPLICATION DOES NOT GUARANTEE THAT A VENDOR WILL BE ACCEPTED BY THE LOC. DECISIONS OF THE LOC WITH REGARD TO ACCEPTED VENDORS ARE FINAL.**

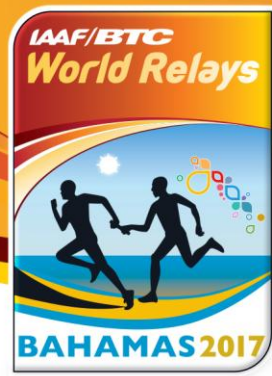
